



Dear Hoo-Hoo Members: The Canadian Forestry Association of B. C., is a nonprofit, non-political organization,

devoted to the promotion of the

wise use of our renewable resources To help promote the "wise use" of our forests, we are developing a Forestry and Logging Museum at our Silver Lake Forest Education Centre (located in the centre of British Columbia) which will be used by school teachers. students, summer campers, and the general public to get a better appreciation of the forest industry and to look back at the "interiors" logging history.

It is our intention to start with the horse logging era and have artifacts that show the industry through the past number of decades. Displays will be both indoors and out, and will include forest protection equipment. hand tools, vintage mechanical logging equipment, and technical artifacts.

We plan to set up displays showing what the old blacksmith shop looked like, and a typical old fire look-out tower, complete with radios, fire finders, etc.


The Silver Lake Camp is celebrating 10 years of operation this year. It is used extensively and up to 70 campers spend three to seven day sessions in log buildings, and are taught forestry, and forest related subjects like map reading and how to use a compass, tree identification, and more.

A native of North Carolina. Griffith manages a 135 acre Tree Farm in Dare County, N.C., which has been certified by the American Tree Farm system, sponsored by AFI. The program now in its 40th year encourages 41,000 Tree Farm members to manage their 82 million acres of forest lands for greater productivity.






