MEMO FROM THE SNARK

As of writing, mid-December, I am pleased to report that our paid membership is between 4 and 5 percent above last year. This does not necessarily mean that our numbers are swelling at a faster rate. It could be that we are collecting dues more efficiently, however I live in hopes, and I am certainly encouraged by our current status.

We have not been in a better position for some time, to achieve our desired 10% increase. Keep up the good work!!!! Someone out there is really trying.

Your international officers should have been in touch with you by now, and hopefully have something to report on the 5-On-1 membership and retention program, and the participation in the projects we have undertaken this year.

The above programs are intended to help clubs who do not have any systematic membership program, or who do not have any industry related projects. Many clubs already do an excellent job. Many clubs do nothing at all, and it is to these clubs that we direct these suggestions.

Boston concatenated 34 kittens last year. They immediately implemented what could be called a version of the 5-On-1 Program. Rameses Jack Jacobson introduced to them, a system where

I kitten is elected "Keeper of the Scroll," the Scroll usually being a roll of good quality toilet paper, on which are inscribed the names of the other kittens, who accompanied him through the onion patch. He is then responsible for contacting the other kittens before each meeting to ensure or encourage their attendance. The results were as follows...during Boston's pin presentation ceremony in May this year (6 months after concat) 26 or 28 were on hand to receive their pins, and of the 8 members of the concat team this year, 7 were kittens last year and were deputized by the "Keeper" to help call others during the year. I understand that the Keeper of the Scroll is also considered for a position on the board, following a successful year of duty.

I attended both concats, and as it was a pleasure and a change, to see guys who were introduced to our order in a way that only Boston can orchestrate, be in attendance a year later, as enthusiastic and contributing members.

Praise must certainly go to the Boston Club's officers and board, for their encouragement and implementation of the "Keeper" policy.

If you have suffered a high attrition rate of kittens, perhaps this could be your answer, and also takes the burden off the club officers, at least as far as keeping kittens. A committee to contact existing members who haven't been seen for a while, is also important.

I want to again raise the subject of considering permanent secretary/treasurers. You don't need to be a genius to process the necessary paperwork, to run a club and prepare returns to H.H.I., but there are certain qualities that are absolutely necessary, to do a good job. This position should be taken out of the stepping stone process of attaining presidency of the club. It is impossible to elect a new Sec./Treas. every year, and expect good results. Please, please consider appointing a reliable, conscientious and organized person and keeping him. Sometimes there are older members, perhaps retired, who, in the case of smaller clubs would take on the job in return for covering his annual dues and meetings, meals etc., and with larger clubs (who for the most part, became a larger club because of the dedication of a few permanent enthusiasts), paying a salary, or reimbursing in some suitable manner.

Billy Tarpley, your executive Secty./Treas., will be bald one day, as a direct result of good intentioned, newly elected S/T's, who, when they finally grasp the situation, will hand the job off to some equally good intentioned, but unfortunately inept new guy. It's tough to knock guys who are volunteers and trying to do their best, but brothers, I believe that this problem causes 30 to 40% of our membership problems.

Have you heard the story of the guy who joined in January and was still asking for his pin in October? You usually hear about it as you are fining him \$1 for not wearing it!!!, or the guy who was dunned by H.H.I. after Dec. 9th, for dues he paid his club in September. Really makes for good p.r. and has accounted for many a disgruntled ex-Hoo-Hoo members.


Jurisdiction VIII

Former International Secretary/Treasurer W.A. "Bill" Russell L-50220 passed away at his home in Buchanan Dam, Texas on November 27, 1988 after a lengthy illness. As a result, the entire Hoo-Hoo world is saddened, but also strengthened for having known a man of such conviction and dedication to our Order.

Bill Russell is credited by many for being primarily responsible for pulling Hoo-Hoo International out of deep financial hardship in the 1970s due to his restricted spending policies, but priior to his service as international secretary/treasurer he had been working for the good of Hoo-Hoo in many ways.

The letter below was written by Bill's good friend, Rameses 72 Jimmy Jones of Napa, California. Jimmy tells us that not only has Hoo-Hoo lost a good friend, it has also lost a great leader.

"Bill Russell was Hoo-Hoo all the way," Jimmy writes. "I first met Bill in 1964 at the international convention in Toronto, Ontario. This was the first international convention that Betty and I attended. We knew only three people and they were all from J-VI in attendance at the Toronto convention. Bill kind of took us under his wing and saw that we got to know many people from all over Hoo-Hoo Land. Many are still good friends today. Bill had already attended twelve international conventions when we met him in Toronto.

"Bill was the president of Houston Club No. 23 in 1951-52. He served as State Deputy Snark in J-VII in 1955-56, was elected to the Supreme Nine from J-VII in 1969-70. Also he was the chairman of the international convention held at the then-new Shamrock Hotel in Houston in 1954. During all these years, Bill worked at the local level, jurisdiction level and for the international order. In 1976 at the convention in Albuquerque, New Mexico, Bill was elected to the office of international secretary/treasurer. He held this office until 1981 when he retired from Rockwell Lumber Company and moved to his beloved hill country of Texas.

Bill was involved in many other things too numerous to mention, but I must say that we was involved from the start on the in Palestine, Texas on May 5, 1910 and lived in La Porte, Texas Hoo-Hoo International and Forestry Museum, and the transfer of the international office to Gurdon.

'All that knew Bill Russell are very fortunate to have known such a great Hoo-Hoo. Fraternally, Jimmy Jones, Rameses #72.

A man of Bill Russell's stature was destined to make an imman of high principle who believed and lived every word of Hoo-Hoo's Nine Point Golden Rule. He was a man who knew his

ground and stood it well, and never shirked a confrontation when he knew he was right.

His loyalty to Hoo-Hoo was second to none, as attested to by his friend, Rameses 52 Dick Scott of West Vancouver, British Columbia. "Hoo-Hoo has lost one of its most dedicated members," wrote Dick. "Bill was on the Supreme Nine when I was Snark in 1959-60. Bill and Nan were very close friends of Isabel and myself, and I feel very saddened by his death.

The obituary in Bill's local newspaper stated that Bill was born until he and his wife, Nan, moved to Buchanan Dam in 1980. Not only was Bill active in Hoo-Hoo, but he maintained membership in the Rotary Club of Houston and the Episcopal Church.

Bill was concatenated into Hoo-Hoo in Houston on May 31, 1948, and in 1952 he and Nan began attending international conpression on all who had an opportunity to meet him. He was a ventions. 


Oh, the liquor was spilt on the barroom







Bailois and his assistant, Nancy Johnson, presented a series of slides that showed the development of the municipal airports since their beginnings back in the 30's. He described the extensive remodeling that is underway at Mid-Continent and gave us a preview of future expansions including the new parking garage. The notable exception is Delta and he says it will be serving Wichita but he just can'tsay when. One of the reasons that so many

One of the photographs he showed us revealed new taxiways leading nowhere. He says that there are some great things in the works. He noted that he can't talk about them yet, but to keep an eye on that area. The results elsewhere have produced enough negative effects so as to outweight the positive benefits that are perceived to be derived from such a facility. 

UPDATE: HOO-HOO PARK: AN EDUCATIONAL FACILITY

On December 1st, 1988, Ron Thompson and Frank Gray presented to the members of the Central Florida Hoo-Hoo Club No. 115 details of the Hoo-Hoo Park project.

The members present were enthusiastic and very interested in knowing more about the project. As we all know in Florida, Club 115 and all its members are the leaders of Hoo-Hoo in this state.

There were several members present that donated and pledged about \$800, and Club #115 donated \$1,200 to help the park on its way.

If the other clubs would assist in any way they can, it looks like the education park, always to be known as Hoo-Hoo Park, is off to a start.

Below listed are the trees that are on the property and most of them will be left visible from the boardwalk:

Mixed Hardwoods

The mixed hardwood community is located on the U.S. 1 frontage and along the western half of the north property line. At these frontage areas a thick growth of wild grape vine covers the canopy. Under these vines is a dense saw palmetto thicket with a canopy of myrtle oak and wax myrtle. Both the myrtle oaks and wax myrtles seem to be adversely affected by the dense coverage of wild grape.

Further into the mixed hardwood community the wax myrtle and myrtle oaks become more abundant and red bays are observed. Bracken fern, swamp fern and cinnamon fern are also noted as associate understory plants.

Temperate Hardwoods

The next plant community which is encountered on the subject property is that of the Temperate Hadwoods. Emerging from the dense saw palmetto understory of the mixed hardwood into the fern dominated Temperate Hardwood community is spectacular. A mixture of swamp fern, cinnamon fern, and bracken fern dominate the understory. Sparse groupings of saw palmetto are scattered about under the dense canopy of sweet gum and red bay. Two landmark trees are grouping.

Mixed Wetland Hardwoods


Further into the site is a large area of mixed wetland hardwoods. This community, like the temperate hardwoods, is characterized by a canopy of sweet gum and red bay, but it also includes red maple, mockernut hickory, sweet bay, loblolly

bay, and a greater number of cabbage palm. The understory vegetation and hydric soils truly define the "wetland" classification of this area. The understory is comprised of swamp fern, royal fern, Virginia chain fern, netted chain fern, Jack-in-the Pulpit, lizard tail, and duck-potato.

The soil in this community is very moist. This condition is due to the high water table, not from periodic inunduation by the Indian River lagoon. The existing vegetation is specific to freshwater wetlands.

Tropical Hardwoods

A very small community of tropical hardwoods is found on the southern boundary of the property near the shoreline. It is dominated by gumbo limbo and also contains wild coffee, marlberry, and (Continued on next page)





MUNN (MEINROD) SCHERER L-45172

Hoo-Hoo International and the Twin Cities Hoo-Hoo Club No. 12 lost a very fine member and friend with the passing of Brother Munn (Meinrod) Scherer L-45172, age 80, of Medina, Minnesota on Friday, October 22, 1988.

Brother Scherer was co-founder of Scherer Bros. Lumber Co. in Minneapolis, one of the largest lumber companies in the Midwest. He had an eighth-grade education, and started in business with his brother, Clarence, to reclaim and saw old white pine logs that they dredged out of the Mississippi River. Industry authorities said the logs may have been in the river for up to 50 years, having sunk during earlier timber harvesting.

Scherer Bros. Lumber Co. now employs about 250 people, ships lumber in an area between Chicago and the Dakotas, and is a landmark along the Mississippi River in northeast Minnesota.

Brother Scherer was concatenated into Hoo-Hoo on June 10, 1937 in Minneapolis and maintained his membership in the Twin Cities Hoo-Hoo Club No. 12. where his son, Mike Scherer 80095, also holds membership.


