

From Jurisdiction IV, we have news that we are soon going to have a new club in Aukland, New Zealand. Jurisdiction IV is really spreading out


All Jurisdictions are reporting Concats and many diversified meetings from Industry nights to just plain fun nights, Ladies Nights, and even family get togethers.

Kellogg Foundation of Battle Creek, Michigan, to provide the first major funding for the Institute's program, and to staff the program with experienced business professionals and to develop a sustained effort to promote enterprise development in Maine.





His horse is 145 feet (44 meters) wide, or the size of five locomotives. The carving, begun in 1923, was completed in 1970 several after lengthy interruptions.

Stone Mountain is the world's largest mass of exposed granite-more than five miles (eight kilometers) in circumference and 583 acres (236 hectares) of exposed surface. It is estimated to be 285 to 294 million years old.

Surrounding it is a 3,200 acre (1,295-hectacre) educational/recreational park with lake fishing and riverboat rides; authentic, 18-building antebellum plantation; skylift and hiking trail to the top of the 825-foot (252-meter) mountain; scenic, steam-powered railroad ride around the base; game ranch, antique auto and music museum; exhibits of the 1861-1865 Civil War in Georgia; 90-room inn and facilities for swimming, picnicking, golf, tennis, camping and boating.

Stone Mountain Park is 16 miles (26 kilometers) east of Atlanta.







"HOW TO RAISE KITTENS"

Give them something to do during their first year in Hoo-Hoo. This will help them feel that they are a part of our organization.

Have the kitten understand that the initiation is merely the first part of his becoming a member. The second part is serving his "kittyship", much the same as a doctor serves an internship for a year or two following his graduation. During their "kittyship" a kitten can and should be asked to do certain things for the club. Examples are selling raffle tickets, writing a news release, picking up another member for his meeting and most important of all, signing up two additional members during his"kittyship".

Put the kittens on your meeting call list. Assign members to each kitten to call for each meeting thereby affording the kitten the opportunity to meet other members in his club.

Most important of all, keep introducing yourself to new kittens so that they continue to feel important to your club. Ask a kitten to sit next to you at your next meeting. Better yet, bring a kitten to your next meeting.
