ll systems are "go"! The 153-day countdown begins! The outstanding convention planned for Hoo-Hoo, their wives, guests and friends looms on the horizon in beautiful Victoria, the capital of British Columbia. It is obvious that September 11-15, 1983, will be truly red-letter days on the Hoo-Hoo historical calendar.

Arrangements and staging have been by the Victoria Club No. 48 but it is obvious that a project of this magnitude requires the cooperation of not only those in the club but of a much larger group of members. We are confidently state that at least the western part — if not the whole — of Jurisdiction V has been a part of the arrangements. As far as we can determine Fred Frudd No. 73230, Supreme Nine Representative for Jurisdiction V has been in on most of the meetings.

"I was appointed Chairman," writes President Doug Donald No. 77244 of the Victoria Club, "but the real Convention Chairman has been Jim Redecopp No. 87893 and the Board of Directors of the Club." The club and its Directors and members and members and Officers of many other clubs in Jurisdiction V have made it a real joint cooperative project. We might point to this as a demonstration of the best in Hoo-Hoo traditions and principles.

This will be the first visit to Victoria for many of us, for others it will be another of frequent visits. But if the city, the hotel and the convention live up to the minimum of our expectations we are in for the experience of a lifetime.

The city with a metro population of about 232,000 is on the southern tip of Vancouver island. It is a two-hour ferry ride — about twenty minutes by air — from Vancouver. The

climate is the finest in Canada — 2,000 hours of sunshine annually — temperatures: January 4 to 5 C, August 20 C to 11 C; less than 5 cm average rainfall. It is officially classed as Mediterranean.

Beauty and charm are everywhere; understandably the city hosts two million visitors annually and is a prime retirement area. The Butchart Gardens pictured on the front page of this Log & Tally are but one example. The graciously ivy-covered Empress Hotel — site of the convention — features many attractions of a modern hotel and adds tea in the lobby in the afternoon. The Legislative Buildings are beautifully illuminated in the evenings.

The Empress and the Legislative complex dominate the harbor. It is a harbor that boasts the largest dry dock on the North American continent.

A novice visitor to Victoria — or even a veteran visitor — may enjoy spotlighting a few of the other attractions in store for us: Hanging baskets of beautiful flowers on the lamposts, Crystal Gardens; Bastion Square with its interesting 19th century buildings, restaurants and museum; the largest carillon in Canada, and one of Canada's largest museums.

Victoria — named for the Queen who ruled England for more than 60 years — has its roots in deep in English heritage. It is a city attempting to modernize without sacrificing its beauty, charm and appeal.





Vancouver Club's Fantastic Gift To Gurdon Hoo-Hoo Museum


ow would you saw a round log into planks if you had no power saw or similar power equipment? The whipsaw is one answer to this very old question; and answer that was in vogue many years ago and could still be used if there was no other obvious answer. It involved placing the log on a platform and utilizing the services of a top sawyer and a bottom sawyer. Day after day they pulled a long saw, similar to a cross-cut, up and down, up and down.

The old whip saw method is the inspiration for a fantastic acquisition recently received in the International Hoo-Hoo Forestry Museum. The realistic and detailed carving of a whipsaw team in action is greatly admired by everyone who visits the Museum.

Vancouver Hoo-Hoo Club No. 48 fashioned and planned the carving from cedar. When it came to the Little Rock Airport we were advised that a large heavy package had arrived, valued at \$800. The attendant advised us that we may have some difficulty getting it through Customs. It would be necessary to convince customs officials that we had no plans to sell the item when it cleared. After hiring a consultant and writing letters of assurance, we cleared customs and transported the item to its permanent home in the star spot of the Museum.

We credit Vancouver Club No. 48 with obtaining, planning and delivering an outstanding display. Club President Omar Derkach supplies us with the following information about the carving:

Elmar Schultes carved the display all by himself. He is an expert with long experience and worked with gouging tools and mallet and knives which he designed and made himself.



The work probably required twelve to fifteen hours of careful, painstaking labor plus a lot of love for woodcarving.

Believe it or not the carving is all one piece except for the small jugs and cups. We assume that these contained coffee and oil for the saw. The wood carving is from Western red cedar and it represents a real-life scene that many people now living still remember.

Fifty to sixty years ago the whipsaw was a common sight in the Yukon and Western Canada area. Now it is a sentimental reminder of pioneer days and a testimonial to the ingenuity and energy that enabled them to succeed on the frontier. In the Yukon today on special celebration days, one can see whipsaw teams in contests using the frontier days mechanism to demonstrate skill, strength and endurance.

The carving was crated and shipped to the Museum and contributed by members of Vancouver Club No. 48. It was valued at \$800 for

The ideas came as a kind of community brainstorming by the members of the club. It seemed to represent a unique example of the utilization of forest products. Also it was unusual - a one-of-a-kind production that just could not fail to catch and hold the interest of everyone.

No item in the Hoo-Hoo International and Forestry Museum has attracted more careful scrutiny, more questions, more camera flashes. A few old timers exclaim with delight, "Gee-an old whipsaw!" We have studied the carving from every angle and though we have not been in forestry long enough to testify to its

authenticity, we are fascinated by its detail and by the carving as a work of art.





The meeting was an outstanding success promoted enthusiastically by the club's directors, officers and members. Ron Jahns No. 84633 is President of Club No. 139.



DEVASTATING FIRE HITS SOUTH AUSTRALIA, MANY HOO-HOOS SUFFER LOSSES

All members of Hoo-Hoo will have heard of the disastrous Australian bushfires which occurred on Ash Wednesday, 16th February, 1983.

The most serious and devastating fire was in the southeast of South Australia just north of Mt. Gambier which is the base of the well known Hoo-Hoo Club 214

This special fire report was prepared by Brian Page, 82335, Publicity Officer of the club.

The day began hot. The country was already tinder dry after a prolonged dry spell. By 1 p.m., the mercury had climbed to 1110F, the highest recorded temperature for 46 years and this heat was accompanied by scorching winds averaging 25-40 mph. The peak wind gust was of 65 mph recorded at 4 p.m.

Just before 1 p.m., two fires began in prime farming country north and west of a little town called Furner. Billowing white clouds of smoke filled the sky and the whole district went on fire alert! The small mill town of Mt. Burr organized and waited. People began plans to evacuate the thin line of wooden houses which clung precariously to the road through the pine forests.

Already sketchy reports of massive losses of property and stock and the possibility of some deaths were broadcast.

The radio frequency used by firefighters talked of fleeing fire-crews and people. Waiting people felt a chill of fear in their clenched knuckles.

Then the worst happened — trees were blown onto power lines near Mt. Muirhead at the forest edge, west of Mt. Burr. A new fire began at about 3 p.m. and exploded without warning, driving through the forest all around Mt. Burr. The stunned townspeople fled for their lives to the only safe place, the green oasis of the football ground in the center of their fragile town. There was no time at all, only a warning to run for your lives.

These three fires quickly combined into one, fed voraciously on the magnificent pine forests in the Mt. Burr Forest Reserve, devouring 90 percent of the once proud 13,676 hectares. This fire storm burst out of the forest in a 10km front and ran at great speed in the direction of Mt. Gambier.

In its wake, workshops belonging to two long haulers blazed away threatening the Mt. Burr Sawmill area. Peter Huckel, 88193 and Bob Long, 78078 had lost their vital home-bases plus valuable equipment stranded in the forest.

The smoke was now a telltale black. At 3:30 p.m., smoke and ash filled clouds obscured the sky, the sun was a blood red ball surrounded by seething black and red. Ash was falling over a wide area. The town of Portland, 100 km away was darkened like the rest of the district. The townspeople of Mt. Gambier watched without realizing the danger.

By now, the fire had leap frogged 20 kms from Mt. Burr to Kalangadoo at the north of the fire front. Homes were lost, communications were in a desperate state of urgency. Firefighters fought to save the Glencoe area in the south of the front. The fire raged through Dismal Swamp and into Wepar about 20 km from Mt. Gambier. This threatened pines to the north of the Mt. Gambier airport. It was four o'clock and a sudden windchange from the southwest gave relief to Glencoe and Mr. Gambier.

The cooling winds dropped temperatures immediately, 1020F at 4 p.m. became 81°F at 4:30 p.m. but the maximum wind gust of 65 mph was recorded. The freshening winds drove the fire harder, the whole length of the fire ran with this wind in a new front of 90 kms long. The town of Penola was threatened and the forest towns of Nangwarry and

Tarpeena were overrun. Desperate firefighters saved the Nangwarry mill and town but Tarpeena was ravaged by cruel fingers of flames. The Sapfor mill area was ablaze and many homes were burnt. The townspeople fled to the safety of the oval and blessed a couple of individuals who had the foresight to have set it up as an evacuation area. Panic became apprehensive calm as darkness fell.

The valuable Penola forest area was extensively burnt but somehow, the fire, satiated began to slow. The cooler temperatures, a few drops of night rain and the wind which dropped eased the situation. Firefighters were able to stop the fire in open country. Black-burnt areas denied the fire its vital fuel.

Meanwhile, fierce fires burnt in the area behind. Club members at Sapfor were fighting a massive fire which burnt stock, outbuildings and sheds. Somehow, the recently modernized mill and vital boilerhouse and kilns were saved. The office was scorched but also saved.

Next morning, the counting of losses began. Stunned firefighters mopped up or watched still burning fires. The terrifying reality of what had happened began to sink home. Many families cried for lost family and homes and farmers stood in the ashes of a life's work. The fertile farms, heavily stocked with breeding cattle and sheep, many sent to this refuge to escape from the drought, were blackened and only charred animals remained. Native animals and birds were nowhere to be seen or heard in the deathly quiet. Foresters looked at the ashes and planned the massive salvage operation - thank God the mills were saved.

Some of the losses were:

20,000 hectares of pines of age 1-50 years valued at \$80,000,000, 25 percent of the local forest area. One estimate of lost wood was 6,000,000m³.

Farm property and stock losses of \$30,000,000. Any hope of farm incomes lost for a year or more.

1,500 square km burnt or 8 percent of the southeast.

220,000 dead sheep.

10,000 dead cattle including dairy

100 odd homes.

Uncounted vehicles, equipment, farm buildings, hundreds of kilometers of fencing


14 people dead and many injured, some seriously.

The whole district is now engaged in the massive salvage and clean-up operation which effects everyone including every member of club 214. Some are directly affected, many others are heavily involved through their work, others have volunteered and are working to help the many farmers in desperate trouble or giving emotional support to those worst affected. The great Australian spirit is evident everywhere and will be needed in the several months ahead.

The members of Club 214 thank all those that have sent messages and kind words of support or offers of help. They were much appreciated.






RETAIL LUMBERMAN AGAIN FEATURES THE ACTIVITIES OF HHI


