## **VICE PRESIDENTS' REPORTS**



### DAVE BLASEN 53110

We have just returned from the International Convention in Leura, N.S.W., Australia. What a wonderful six days of meetings and fraternalism.

The host clubs--Newcastle 237, Woy Woy 260, Sydney 214, and Canberra 232--in conjunction with the convention chairman, Tony Hobson, did a tremendous job to see that everything ran smoothly. The two years of work behind the event was evident, and the result was an excellent convention.

As is customary, assignments were given out at the Board Meeting. My assignment is membership. So, I set out to learn a little about Hoo-Hoo's membership and here are some of the facts I uncovered:

Membership is 1956-57 was an impressive 13,844;

By 1990-91, total membership had dropped to 6,063, reflecting a drop of 591 members from the prior year;

Hoo-Hoo International has shown an increase in membership from one year to the next in only 13 of the last 35 years.

The numbers are disconcerting and are reflective of a trend which, if it continues, will bring the end of a valuable fraternal organization. The numbers also spell out my task, though, and I am confident that with your involvement we can turn around that trend.

I have been given the assurance by each of the Supreme Nines that they will support your club in its membership drive. To facilitate that effort, I will be providing an outlined membership campaign to the Supreme Nines; they will, in turn, share this plan with your club.

Basically, I see that the declining numbers can be turned around with focused action in three areas--Retaining current members; Reinstating members who have dropped; and Recruiting new members. The membership campaign your Supreme Nine will bring to you will revolve around these three R's.




### FRED SCHEFFLER 89278 SUPREME NINE, J-III


### **DAVID JONES L-82806** SUPREME NINE, J-VI

## JURISDICTION

Hoo-Hoo in J-IV has fared far better than our industry has over the past year. I am more than delighted with our membership when one considers the vast numbers who have lost their jobs as a result of the downturn in the Australian economy. We started this year with 1112 members and finished with 1060, a net loss of 4.7%. I have been associated with our industry for over 40 years and have never seen anything that resembles the market conditions we are living with today, so all one can say is that it shows the strength of Hoo-Hoo in our country. The clubs with real gain this year are Auckland 248, up 37% and Perth 240, up 17%. Congratulations to these clubs for a great effort. As mentioned before, Burnie Club 272 is performing very nicely, we unfortunately have not been able to get other new clubs under way. The starters are Leschenciultia (Bunbury W.A. area) one in Victoria (Bairnsdale) and one in New Zealand, but I believe these clubs can be up and running when we see some improvement in the economy. People are very reluctant to commit themselves when there are so many uncertainties around, and I don't blame

I have visited the following clubs during the year: five visits to Launceston; two visits to Hobart, Melbourne, Sydney, and Perth; and one visit to Burnie, Adelaide, North East Victoria, Canberra, Manjimup, Geyserland, Southern Club, Brisbane, Mt. Gambier, Ballarat, and Newcastle; plus a joint meeting of Launceston and Hobart for a total of 26 meetings.

Unfortunately, I have not had time to get to Woy Woy 260, as I have visited Dick Campbell's home at Woy Woy on four occasions for the 99th Convention Committee meetings.

I traveled to Mt. Gambier for our J-IV Convention held in October 1990, and to Hot Springs and Gurdon in March '91 for the HHI Mid-Year Board Meeting, a total of 73,000 kilometres. 




