

Some more Prosperity Peas, Please! After last year, why take a chance?

In our house, New Year's Day isn't just about bowl games, it also includes a bowl of prosperity. A spoonful of tradition that is heaped with hope for the year to come. Every New Year's Day, we boil up some Black Eyed Peas.

Our lumber yard has been handing out bags of these dried legumes to our customers in hopes that good fortune will fall in all our favors. We like the idea of starting the New Year on a positive note. To heck with resolutions that are impossible to keep, a bowl of beans is all we need to bring positive change.

Curious about the tradition, this is what I found. Originally native to Africa, this pale bean with the prominent black spot was introduced to the West Indies and the American South in the 1700s. Some historians say, however, the tradition of eating black-eyed peas on New Year's Day for good luck dates to the Civil War.

Union troops under the command of Gen. William Tecumseh Sherman confiscated nearly every Southern foodstuff they could carry on their march to the sea. But the Northern soldiers considered black-eyed peas to be suitable only as animal fodder and left them in the fields. Many Southerners survived on this humble staple as a result.

Wherever the origins of the black-eyed pea, the Good Luck tradition has been carried down from generation to generation. The idea is that if you start out the New Year dining in humility, you will only become more prosperous as the year moves on. Some cook the peas up and serve along with greens and cornbread. According to the myth of fortune, the peas represent coins, the greens symbolize paper money, and cornbread stands for gold.

NEW YEAR'S BLACK EYED PROSPERITY PEAS

1 cup of dried black eyed peas

1 ham hock or 1 cup ham cut in large bites

1 quarts of water (plus more if needed during cooking)

1 small finely chopped onion

1 carrot chopped

3/4 teaspoon of salt

3/4 teaspoon dried thyme

1/2 teaspoon of crushed red pepper

Soak the black eyed peas for at least 2 hours. Drain and replace with fresh water. Add all ingredients. Let it cook for 45 minutes, adding water if needed. Serves 2 to 4

May your New Year start with humility, but quickly be filled with fortune—whether that fortune is financial or family and friends. We are all rich one way or another. But, it doesn't hurt to pepper the pot, so to speak!

So, throw another log on the fire, good things are coming your way. May your 2011 be filled with health, happiness, and long life.

First Lady of Hoo-Hoo

Stirring Up Ancient History

In the previous issue of LOG & TALLY our Editor referred to me as "Hoo-Hoo's unofficial historian" and that got me thinking... Have we ever had an official one? I don't know the answer, but if we did, I believe the role should be called "Honorary Hoo-Hoo Historian". I'll tell you why with a little numbers game I like to play. Ready?.

That title, onorary Hoo-Hoo Historian, contains four 'H' words and 'H' is the 8th letter of the alphabet. It follows logically then that, $4 \times 8 = 32$. 3 + 2 = 5. Add the original 4 (from the H's) and that = 9, and nine is rather special in Hoo-Hoo! So if there were such a position, I'd put up my hand, but more about that at the end of this story. Let's first stir up some Hoo-Hoo history.

Spoon with me, anyone?

Do I collect spoons? No, but let me tell you about two special spoons I happen to know a little something about.

Spoon Number 1: The Hoo-Hoo House —Information published by the University of Washington Alumni Association tells us that the Hoo-Hoo House, which also served as the University of Washington Faculty Club, was dedicated on June 9, 1909, the ninth day of the Alaska-Yukon-Pacific (A-Y-P) Exposition's forestry exhibit in Seattle, Washington. Two huge statues —Black Cats, of course—guarded the entrance to the house. Both had green electric eyes that glowed at night.

Following the dedication ceremony, local Hoo-Hoo members hosted a wedding at the house that was attended by, naturally, 99 persons. As the story goes, the Hoo-Hoo gave the famed "Hoo-Hoo Yell" right after the vows, frightening the big black house cat, Bandersnatch, who jumped out of the window and scurried off into the night.

"So, what does that have to do with spoons?" I hear you ask. What may not be so well known is that the Hoo-Hoo House had already featured at a previous exposition. Some years ago, I was delighted to acquire a commemorative enamel spoon from the 1904 St. Louis World's Fair on which is depicted the "House of Hoo-Hoo".

My father used to say, "A trouble shared is a trouble halved, but a joy shared is a joy doubled"! Earlier this year, I was able to double my joy by sending one of the spoons to Vancouver, Canada, as a special gift to my friends, Rameses 79 Jack and Norma Jacobson on the occasion of Jack's surprise 80th birthday party. My Dad was right and this was confirmed when Jack and Norma telephoned us in Australia the next day!

HISTORY OF HOO-HOO

The engraving of this spoon is of our International motto, Health, Happiness, Long Life. Spoon Number 2: Silver Hoo-Hoo Spoon —More recently, in my ramblings on the wonderful World Wide Web, I came across a specialist sale of a collection comprised of "American and foreign enamels, demitasse, skylines, Exposition and sterling American souvenir spoons". Just one of them caught my eye because it was described as "A Hoo-Hoo Sterling



Souvenir Spoon" — and that's exactly what it was. There were a few minor obstacles to overcome before I could negotiate for it from as far away as Australia, and my thanks are due to Clare Imholtz and Nancy Willett who were instrumental in assisting me to acquire this fine example of Hoo-Hoo memorabilia.

The published, detailed description included the following: "Handle: Nicely embossed plume design at the top; one plus inches of caput is enameled with nine green and brown cattails below a black cat in a gold circle, all on a white background; below cattails is some design, embossed tiny flower, rest of handle is a lined design. Bowl: Sideways, nicely bright-cut engraved "Health Happiness Long Life." Reverse: Back of embossed plume design and flower and leaves; fancy outline design; "Iris 3566" engraved sideways in caput."

Should I Explain?

As can be seen from the photographs, the "black cat in a gold circle" is, of course, our standard Hoo-Hoo emblem. However, the design beneath it is wonderfully interpretive. The "green and brown cattails" are stem flowers of the Common Cattail plant (Typha latifolia) and there are nine of them, in two rows, of five and four - a veritable Nine o' Cat Tails!!

Now I don't know whether silver spoons were created for partners at Hoo-Hoo Conventions or special functions, but my hypothesis is that this one was for Iris, the wife of whoever was Hoo-Hoo #3566. So, for want of any better hypothesis, I sent a quick email to our ever-reliable Executive Secretary, Beth Thomas in Gurdon, Arkansas and asked her to check some records.

(Incidentally, has anybody ever noticed that if you shuffle the letters that make up the word "Arkansas", you get "As a snark"?)

Beth told me that Hoo-Hoo number 3566 was issued at Concatenation 261 in Carroll, Iowa, on 3 September, 1895, to David Milligan. Remarkably, his full name is listed as David Scotch Rye Milligan! Earlier that year, at Concat. 231 in Des Moines , Iowa on 16th May, Elmer Augustus Milligan had become a member of Hoo-Hoo with the number 3298. He was Vice President of E. A. Milligan and Son Inc., a Des Moines company involved in lumber yards and grain elevators.

Of course, I had hoped I'd be able to find out just when the spoon was created but we haven't quite got there yet. However, just from the basic records, I think we learn some other matters of interest. For example, after the Order was founded in January 1892, no less than 3,298 men from the lumber industry had been inducted into the organisation during the first three years and four months. Then at least a further 268 became members in the next fifteen weeks.

HISTORY OF HOO-HOO

At this stage, I don't know much more about the Hoo-Hoo activities of the Milligans but their involvement was obviously endorsed by the family because more than fifty years later, two more David Milligans became members. Also, the business had obviously thrived because when David O. Milligan #52103 joined in 1949, he was listed as President and Owner of E. A. Milligan and Son Inc. and David D Milligan #57739 who became a member in 1952, was listed as Vice President.


Further ferreting on the web confirms that the US Dept. of the Interior's National Park Service's National Register of Historic Places lists a 1951 house in the Ashby Manor District of Des Moines at Lot 4129 Ovid Avenue, as a 2-story ranch, wide clapboard, brick chimney, overhung second floor at front, 8/8 d.h. windows, gable roof with asphalt shingles and nominates the first occupant as David Milligan, vice-president, E.A. Milligan & Son.

Amazing what you can learn from a spoon isn't it! Oh, and by the way, I'm keeping this one for myself - at least until Jack Jacobson is 99!

So, there you go, "H" is for History! And, other things as well...

How historic, having Howick's hand hoisted high hunting honorary Hoo-Hoo historianship. He has habitually helped Hoo-Hoo handle haphazard harassment. Hundreds have hastily haunted hazardous heights. However, Howick has hardly had hostile horrors. He harnesses historical handiwork harmoniously. Here's hoping Hoo-Hoo helpers have Happy Holidays!

Membership—Increasing and retaining membership has been at the top of the agenda every year for the last 35-40 years. In good times and bad times, in spite of many programs, incentives, changes in eligibility requirements, etc., membership has continued to decline. The most recent by-laws change that expanded membership eligibility merely verified existing conditions. This might explain why there has been no apparent result as of this time. We need to put a positive spin on the unfavorable economic condition we are currently in: This is a time for networking. Membership in the "family" of Hoo-Hoo opens many doors of opportunity

In the past, salespeople would attend the meeting because the people that bought their products and services were there. In the USA that changed during the Clinton administration when it was decreed (by the IRS?) that 50% of dues, meal and related expenses had to be considered as remuneration and charged back as such to the bottom line. Consequently, the owners (stockholders) told management to stop subsidizing such activates. Therefore we cannot expect companies to pick up the bill.

Over the years our industry has changed at a more rapid pace than has our organization. In the process of playing "catch-up," we need to focus on opportunities within the broader sense of our industry. Examples would include truss plants and cabinet shops.

We have to recognize that young working parents simply don't have the time that once was available to our members. Consequently, our activities have to take into consideration how families can be involved.

Marketing—There are two targets – Individuals and Companies. Each has to be approached differently. We have a DVD presentation. We will be developing new brochures.

As far as the individuals, the goal is to stimulate the young people. The question is, what incentives can be identified?

As to companies, it is difficult to convince employers that a "social" organization produces business opportunities and ultimately income. Consequently we must identify incentives for them based on profit and community responsibilities.

This is not a job for one individual. That was tried in the early to mid sixties. At the time we hired one man and provided him with a salary and an expense account. His primary responsibility was to develop new members and clubs. After a few unsuccessful years, his services to Hoo-Hoo were terminated. Instead, this is a job for every member. Ask yourself, how many new members have you brought in the last five years? Why did you join? Remember, you have to ask for the order.

Name Change—There has been some impetus to delete "Hoo-Hoo" from our name. Apparently, some of the younger members are embarrassed when they are asked, "What is Hoo-Hoo?" This issue is not new. Forty years ago it was decided that there should be no name change but, if a local club wanted to identify itself as a wood promotion group, that was OK. That seemed to resolve the issue.

Recent By-Laws Change—As noted earlier, the by-laws change, which was adopted at the convention in Reno, Nevada, in 2009, greatly expanded the eligibility rules for membership. Actually this change simply verified an existing condition. Apparently some of our members felt this was an unwise decision. It should be noted that if there is a need to change the by-laws again, there is a process for that. In the meantime, it is a done deal —move on!

Our thanks and congratulations go to all the members of the Sioux Valley Hoo-Hoo Club 118 for their hospitality and for organizing a terrific event. Special thanks to Bill DenHoed, Roy Edwards, and Todd Kappenman.

Learning Life Lessons from the Richest Man In Town

The Richest Man in Town, written by our guest speaker, V.J. Smith, is a true story that captures the important things in life in an unforgettable way. Like V.J.'s presentation, the book will make you laugh and cry, but most importantly, will make you reflect on what life is about. Marty still inspires people to be better by being just who he was, an honest, caring man.

A very special treat was had by all who attended the Sunday morning general business meeting during the 118th Annual International Convention. Guest V.J. Smith had Hoo-Hoo members laughing, crying, and cheering for more during his presentation in Sioux Falls.

Smith, a professional speaker and former executive director of the South Dakota State University Alumni Association, shared insights and stories about people he had met in his life who taught him great lessons. His enthusiasm for storytelling captured each and every one of us that Sunday morning as he talked about gratitude, thankfulness, earnestness, and Marty, a cashier at Wal-Mart.

V.J. Smith dreamed of writing a book about some great leader that changed the course of history, so he filled his library with biographies of presidents and statesmen. He was looking to find the key to what made their lives great. He ended up finding the man that had that key in checkout line #9 at a Wal-Mart store in Brookings, South Dakota.

Born into a poor family in 1926, Marty Martinson quit school after the eighth grade to earn money to help support his family. He served our country during World War II, then worked at minimum wage jobs for 47 years, never making much money, but appreciating everything he had. After working all his life at other jobs, Marty took a job as a cashier at Wal-Mart for the simple benefits of health care and the opportunity to meet people.


Marty would ask "How's it going and mean it," Smith said. He would walk around from behind the till and stand beside customers in the checkout lane to give them their receipt and change with a sincere "Thank you for shopping here and have a great day," to send customers on their way. The first time he walked around to shake his hand it was scary, Smith said, but

he came to treasure the interaction.

"Marty got what he gave," Smith said.

To Marty, Wal-Mart was heaven because of the opportunity it gave him to interact with people, his people. Marty made a decision to be happy. He looked for the good in people and found it, Smith said.

Smith wanted to let management know what a gem they had in Marty, but after being rebuffed by the store manager, Smith wrote a letter to the BIG Wal-Mart in March, 2000. "The letter that changed my life was that letter I sent that day," Smith said. Being grateful is life-changing, he said.

MAKING A DIFFERENCE

Smith learned through a college student friend of his that Marty wanted to meet the man who wrote the letter. The letter had been received and Marty was congratulated in front of his peers at Wal-Mart.

Smith went through Line #9 and paid with a check. Marty recognized the name, hugged him and invited him to share what became the first of many coffees at Hy-Vee. Smith wanted to know what Marty had to teach, and through many conversations, a book was born. Smith learned kindness, gratefulness and appreciation from Marty. He discovered that any person who has those qualities is rich.

Marty died in April 2004. He received 400 get well cards when he was in the hospital and his was one of the biggest funerals Smith ever attended.

Smith's book about Marty came out in June 2005. Self funded, the first 1,000 copies sold out quickly. Now *The Richest Man in Town* has gone through more than 10 printings and because of the success of the book and his training in public speaking, Smith's life took an unexpected turn.

Smith would happily have served as alumni director for the rest of his career, but the phenomenon that became *The Richest Man in Town* took off for him in 2006. After being picked up by a national publisher, Smith began getting so many speaking invitations as a result of that book that he decided to step away from South Dakota State University and pursue life as a professional speaker. He made 152 appearances—a grueling schedule—during his first year on the lecture circuit. He has slowly reduced his calendar and hopes to trim his annual appearances to about 85. Travel and recovery time is taking its toll, he says. He's been all around North America spreading the word about his friend Marty, the Brookings cashier. "I never expected this," he says, "and we created more work than we ever thought could happen.

"If you chase two rabbits," Smith says simply, "both of them will escape. It's an incredibly different focus to my life, all these requests to speak. But, I'm having fun."

Another passion of V.J. Smith's, sparked by his conversations with Marty and his growing personal observations, is his campaign for thankfulness in everyday life—a theme that runs deep in his presentations.

"When you do something nice for someone, you're not asking for much, just an acknowledgment," he said. "The worst thing is when you get ignored. It's terrible."

According to Smith, people are neglecting to say thank-you all over America. Store clerks don't say it, couples and graduates don't send thank-you notes and people are forgetting it in conversation, he said.

To combat this, Smith carries business-style cards that explain how much a thank-you means and detail how to say it in several languages. Smith threw handfuls of these cards out to the audience surprising us with the delivery while enforcing the message. Through his public speaking, Smith makes a difference one group at a time.

With the success of the book, could a Hollywood movie be far behind? When asked about this, Smith smiled and said, "As I have learned in living Marty's story for the past ten years, anything is possible." Then he added, "With all the inappropriate images and ugly language fed to movie goers these days, especially children, wouldn't it be great to watch a movie fit for the entire family? Wouldn't that be something?" Stay tuned.



V.J. Smith has been a professional speaker for more than a decade. He is also a published author, not to mention a former bill collector, solar collector salesman and a fundraiser. "Being a child of the early '70s, it took me a little while to figure out what I wanted to do with my life," he says.

As for his speaking ability, he credits that with growing up with three brothers and four sisters. "You had to learn to talk loud and fast or you didn't get much to eat," Smith muses. Drawing on his lifetime experiences, Smith peppers his talks with anecdotes and personal stories to illustrate key points. He's a storyteller, not a preacher, but his messages are powerful

Smith honed his speaking skills through his membership in Toastmaster's International. On two occasions he was a finalist in that organization's 'World's Championship of Public Speaking.'

Dear Fellow Hoo-Hoos,




